



As of March 18,2021, I have measured ten inches of rain at my home. Indian Valley reservoir is holding seventy-seven-thousand-acre feet of water just over twenty five percent full and at this time it sure looks like a second year of drought with Clearlake at one point two feet on the Rumsey gauge. Yolo flood and irrigation will not get any water from Clearlake and will sell off IVR water down to twelve or fourteen-thousand-acre feet, as a subdivision we should be ok. Our water system is meant for household use and not for agriculture, so gardeners should consider cutting back this season and please remember pumping water out of any creek without a permit is a crime! So, don't do that!!

If you have pot holes on your street there is cold patch behind the Community Center. When the pot hole is dry, sweep or dig out the loose stuff in said pot hole and asphalt, compact. I use a twenty-five-pound digging bar and it seems to work pretty well. There is very little money for road repaired none for replacement complicated by other problems but still Spring Valley is a wonderful place to live.

March 16th on my morning walk a mature bald eagle left his perch before me fallowed by a larger immature eagle. Many species of water fowl were noticed a sharp shine and many red shoulder hawks were seen fallowed by and of spray looking the creek over for breakfast. I've spent fifty years of my life in the outdoors and it is not strange that I came upon this place to make my home.

CSA #2 ADVISORY BOARD By Helen Mitchem

Our meeting in March saw Special Districts staff and our Supervisor in attendance along with a few interested community members. There was no public input as guests wanted to hear the latest developments on lake recovery. We approved the minutes of our February 3rd and February 11th meetings as written. As agreed upon last month, we asked SDA to hold off on additional engineering work until we confirmed Mr. Van Pelt is still interested in helping us with the project. We will pursue that answer this month. We discussed and agreed to generate a letter to our Supervisor expressing an interest in finding out more about the project Jim Steele brought to us in February. We also heard the weed abatement program for roads and other areas in the valley that should be complete as of this article.

We had open discussion on items of interest with SDA personnel. We talked about the status of the lake recovery project. Ongoing, unknown costs associated with project management was a concern – alleviated when we heard they will not preform that function. It will be SDA personnel. We want to maintain the cost neutral nature of the original project and know we will need a couple of additional permits and studies. Mr. Van Pelt is key to the project and has experience with this kind of work. He'll be working closely with the engineering firm. We discussed the potential sites for spoils from the lake – maybe the mercury site in the Oaks?

In addition, we discussed the following: the code enforcement issues from a meeting last year; the bridge replacements which are on target timing-wise; the new gate for the haul road on Osage; the Quail water distribution project status; and, how the repairs are coming on the "hot box" for road repairs and the possibility of getting a hot tar wand for sealing cracks (especially on Shasta).

Lots of information – thank you Special Districts for bringing it to us!

Our next meeting is April 7^{th} at 7:00pm in the Community Center. We will have more info at that meeting. Hope you can join us.
