CAMPGROUNDS by Helen Mitcham

Campground meeting September 16th at 10:00am in the Community Center.

Tornadoes in Spring Valley? OK mini-tornadoes for sure! You may have noticed the overhang over the front door of the Community Center is GONE! Yep, gone! Got picked up by a mini tornado and dumped about 15 feet south! Crazy, I know. Despite what some may think, this was Mother Nature messing with us! We had already budgeted to paint the exterior of the building this year so we'll add this replacement to that project. Many, many thanks to all the offers of help with this job! A special thank you to Shawn Rudden (life time resident) who called and has volunteered his labor And help from his employer (Bridges Construction). It looks like we have a couple of general contractors willing to help and several of our "regulars" ready to lend a hand. Thank you all! Thank you also to the Special Districts crew for using their backhoe and dump truck to pick up the material and haul it away ... thanks guys!

We'll do an assessment of the siding and replace as necessary before we paint but we want to get the overhang back up as soon as possible. In the next few days, we'll get a light fixture up to replace the one we lost.

We have made the decisions on the lighting improvements for the campground. Upgrades to bathroom and shower lighting will be made before fall ends.

Joe may mention in his article that he has seen bear tracks around the area, so please be alert and careful when you're enjoying the area. Keep your dogs on leash – it's the law and it's there for your safety.

The creek is still very cold (and refreshing) and running fast, so please be careful as you enjoy a dip!

CSA #2 ADVISORY BOARD by Cindy Storrs

The following is an abbreviated version of the minutes from our August 2, 2023 meeting.

Supervisor E. J. Crandall attended and said he's been attending meetings about how to get available funds into the hands of rural communities as well as working on broadband issues. He'll keep us posted as information is available.

CSA #2 Goal report:

- (G#1) PG&E might be undergrounding on Quail Trail, so the paving project to finish the water line project is on hold so as not to dig up a new roadway.
- (G#2) Bridge projects have been sent out to bid. Helen encountered a company (Steelhead Constructors) out of Redding who were in the area scoping out the Chalk Mountain bridge job. The new bridges will be 28' wide and basically the same footprint as the ones being replaced.
- (G#4) regarding the purchase of the hot asphalt machine. This and other road related items will be under consideration at the September BOS Budget meeting. Jim reported a conversation with Scott Harter about pulling those items and getting them ordered in the next two weeks. Special Districts has a new Superintendent. (He lives here in the valley) Once the new machines arrive, some test "patches" will be selected and repaired with the hot asphalt to see the "how to" and to test duration of the work.
- (G#'s 5,6,7) Fire Station windows have arrived. As of this article, windows and doors are in and most of the siding is up as well. Ed reports that the Finance Committee is waiting for the end of the year budget reports so that the committee can work with them. The Finance Committee has asked SD to complete a study about water rates, making sure that we stay with our "water pays for water" Board mandate.
- Items for follow-up: Need to make sure that the emergency generator is being serviced and fueled on a regular basis so that it will be ready in the event of any emergency. Also, when will the permanent generator be arriving? SD has been asked to investigate the daily visits by crew member checking the water system and water tank levels. Are these visits mandated by the State? We don't want to incur unnecessary expense. Following the recent power outage, the emergency generator kicked in however when power was restored, the system did not handle the rebooting of the refrigerators. Food was lost. POA has designated someone to come to the CC in the event of an outage and make sure the reboot is successful. POA is also working to address the electrical issues at the Center.

➤ Osage was once designed as a sedimentation pond area. Will it be used that way in the new design? What is the update on Osage, the purchase and its uses?

➤ (G#3) Has the "package" of the proposal and all the necessary data be sent off to the ACOE?

- ➤ Construction Grant Report (Scott Hornung) All of the grants we are going after are for construction funds to implement the design by Anchor QEA. SDA has filed NOI (Notice of Intent) or applications for six funding grants in excess of \$10M SDA Staff is continually looking for funding opportunities and will research and submit for any grant that appears promising.
- ➤ How much has been spent so far? The original IRWM grant for the Lake Recovery Project was \$945,000. Anchor QEA's contract was for a total of \$563,308.00. There is \$381,192.00 remaining. Anchor QEA's contract covers update meetings, field review, schedule preparations, topographical surveys and mapping, right of way surveys and delineation, hydrologic and hydraulic calculations, simulations and studies, geotechnical work/explorations, grading plans, engineering plans, specifications and estimates for construction of the lake and spoils areas, construction support to respond to contractor questions and inquiries, review change order requests, perform any special inspections and to prepare the final as built plans.
- > We do not know the extent to which Mr. Van Pelt will be involved in this project.
- ➤ Supervisor Crandall has linked Carter Jessup (Super Fund Manager) with Scott Hornung at SD to see if there is a way to use lake spoils at the Mercury Super Fund.
- ➤ Board is still concerned about upkeep costs for the completed project. Will be monitoring things By Consensus the Board was unanimous in their continued support of Special Districts and the Lakebed Recovery Project. The Board will continue to work with SD and the community to receive and share information as it is received.
