

CSA #2 ADVISORY BOARD by Cindy Storrs

Public input on items not on the agenda

• Celebrating the community work done by folks, "Saints" on this All-Saints Day

Info from the EaRTH Meeting

• Problems with kids on 4-wheeler, dirt bikes in the campground and about the valley; dangerous; disrespectful; a community member present shared some information about the family location; possible intervention by an EaRTH member to the school board.

Approval of October 4th minutes Chair Report

- **PG&E Undergrounding:** the roadway will be resurfaced when they are finished with the undergrounding project; current path of the undergrounding if from the beginning of NLV Road to where the pavement ends; undergrounding from where the pavement ends is being negotiated with the private parties who own and maintain the road; *Helen will check with Scott and ask for an undergrounding project map.*
- Water usage & loss: it has been reported that a large, portable water tank has been seen in the back of a silver black/pickup coming into the valley empty and leaving full; Helen asked SD if they would use the cameras placed to capture the identity of the vehicles would be checked for information. Clarifying discussion ensued about the cameras and their use. They are license plate readers purchased with BOS funds. EJ will work to get them viewed.
- Win Cary has written an article for our newsletter and she wrote that someone in your office told her ... "our community water is for in-house use only. It is not to be used for outdoor lawns, plants, or animals." That's not an accurate statement and I'll reinforce the correct message with staff. Our position is that the potable water is for residential and commercial use only, not for agricultural use. This allows for household usage including outdoor lawns, gardens (even up to 6 marijuana plants), animals, etc. in conjunction with a residence. It doesn't allow for large agricultural grows of grapes, walnuts, marijuana, etc. nor large scale animal husbandry operations (herds of cattle or horses). It doesn't allow for those ancillary uses outside of residential or commercial use, i.e. no garden on a vacant lot.

• Helen will inquire with SD about the process for forgiving a proportion of a water bill when the circumstances are extreme, property water leak, etc." This will be a future agenda item so that the Board can explore the issue and possibly make recommendations to SD about the process, the costs, the rate of forgiveness, etc.

- Generator: "Typically our EMT's will test the generator on a regular basis, depending on the generator it's usually weekly or monthly. I suspect, but haven't confirmed, that this is the case for the generator at the plant. When power is disrupted, the crews will check the water level in the tank to determine the urgency for when to run the generator. If tank levels are at the point that the high service pumps would kick in, then the staff will energize the generator, run the plant and the high service pumps, and fill the tanks. At the point that the plant shuts off the generator would then be turned off as well."
- Quail Trail project (G#1) no change
- Bridge projects (G#2) Here is what I got from DPW:
- Chalk Mountain Bridge Replacement Project has been awarded to Stewart Engineering Inc. (SEI). The construction contract agreement, performance and payment bonds were forwarded to SEI for processing. We should hold our Pre-Construction sometime this next month. Project Engineers and Managers are all contacting Steve Phillips, and working with David Bingham on a part time basis to handle construction management for active construction projects. I am checking our permits to determine what construction can be done during the coming winter months (inside the streambed and out).

<u>Upper Wolf Creek Bridge Replacement Project</u> is proceeding well. Our goal is to have a PS&E package at 100% by the end of the year. PG&E surprised me at a meeting in mid-October by asking for three 8" PVC conduits to be included inside the bridge structure. I had imagined PG&E only needing one. Each conduit will land in an appropriately sized junction box on either side of the bridge (to be filled later by PG&E). This seems like overkill on the size and number of conduits, but PG&E will pay for all facilities. Sometime this month I need to ask for federal participation in the relocation of your water main to the new bridge structure.

<u>Lower Wolf Creek Bridge Replacement</u> is the current responsibility of Pablo Pantaleon. As the Project Engineer, he should be able to provide Special Districts with the status of this project. I believe they are still in the design phase of this project

• Hot asphalt equipment (G#4)

"The hot asphalt machine has not been ordered yet...I'm going to bring that process in house and work with our purchasing agent to get the quotes and if I have questions, I will contact Jim. ..I'm sorry it's been a bit since the budget was adopted to get this going, but we seem to have the misunderstandings figured out now." Due to the lateness of the season, it is projected that this work will begin next Spring

• North Shore Station 77 (G#5 & 6)

Fire Station (Station 77) is coming along. The interior structure is in place, the rollup doors are installed; septic system is being installed. The station landscaping will reflect CalFire's mandate (law is currently on the books and enforcement will begin in 2024) of a 5ft bare margin, followed by a 10 Ft minimal margin (low plants) and the 100 ft defensible space margin. The old siren was used to call the volunteers. No plans for an early warning siren at this point. Early Warning Sirens are managed by the LCSO. Finance & Budget (G#7)

• FY 23-24 The Finance Committee is still in limbo. Missing information. Discussion with EJ: what can be done? Is something holding it up? Any issues that are on our side? What can be done to move this forward? Have not received year end 2022-2023. New budget just arrived to us. EJ will follow up and get answers to Helen.

Lake Recovery Project – update

• Permits - ACOE (G#3) "Special Districts, the Biologist and Anchor QEA met with Army Corp and went over the project. From that meeting we are working with Anchor to minimize and avoid impacts to waters of the US as much as possible and then create mitigation for any of the impacts we cannot avoid or minimize. Once we have the revised mapping and mitigation, we will meet

- with Army Corp again to go over the impacts and mitigation and see if they are okay with the level of avoidance and mitigation to move forward. Once they are okay with our level of avoidance and mitigation, I will get the permit application submitted. We have submitted the request to Army Corp for a Jurisdictional Determination, this precedes the issuance of a permit."
- Financing

The grant application project with the Bureau of Reclamation is underway. "The Bureau of Reclamation grant requires a 25-50% match. Amounts vary. We are looking to leverage some of our IRWM grant funds and use them as the match" Helen will write the letter of support and urge SD to consider the income/poverty level of valley residents" This process was used when the water plant was installed and it reduced the required match greatly.

Motion was made to cancel the December meeting and meet again at our regular meeting day and time: January 3, 2024. Approved. Any necessary Board business will result in a special board meeting.
